Program Information

Requirements for admission to early childhood (EC) degree program. Include admission requirements

- Students seeking admission to the Early Childhood Education (ECE) Major with teacher licensure must formally apply and be accepted.
- The admission process into the program takes place once a year in the spring with the admitted candidates starting the program the following fall.
- All coursework within the Center for Educator Preparation (CEP) requires a 4 semester (or 2 year) consecutive commitment to complete, therefore EDUC subject code courses must be taken in the semester indicated.
- Requirements for applying to the ECE major: 1) Must have a 2.75 GPA or better, 2) Suggested to have completed 60 credits (or more) by the end of the semester in which the student is applying (typically students apply their second semester sophomore year), 3) Must have 20 hours of volunteer or work service with children ages 0-8 years (experience must have been within the last 5 years), 4) Must have 3 references.
- All HDFS subject code courses and EDUC subject code courses must be completed with a grade of C or higher.
- Students will be required to pass a criminal arrest record background check prior to participating in field placement courses.
