**In 2006, Colorado established 31 Early Childhood Councils to positively impact services for young children and families by building local early childhood systems throughout the state. Councils provide programs and services to improve the quality of early learning, increase access for children to comprehensive health and mental health services, and provide families with meaningful community and parenting supports. ECCLA was formed as an informal collaborative in 1998 with the intention to bring Councils together to support each other, align efforts, communicate grant management information, share best practices, and to provide local input to state policy decisions. ECCLA was established as an independent non-profit in 2013, launched formally as a membership association in 2014.**

**Family Child Care Home Improvement (FCCHI) Grants:** During a funding round, family child care providers fill out an application online or hardcopy and email to the Director of Workforce Supports. All applications are reviewed for completeness and once it is determined the application is complete, eligible applications are then reviewed through a review committee with 4-6 people. These reviewers consist of statewide early childhood partners, Colorado Shines Raters and the funders if available. Once the applications are reviewed, a review committee is held and together decides on which programs to award and how much. These must be unanimous decisions.

Priorities of this grant are set by the funders and ECCLA, ensuring that projects meet guidelines such as health, safety and maintaining/increasing capacity of the family child care programs as well as geographic dispersion and ensuring those serving vulnerable families are given priority. Once the awards are decided, the Director of Workforce Supports notifies all

The recipients are also asked to complete a Form W-9. Once all forms are returned, the Director of Workforce Supports sends check requests and back-up documentation to the Director of Finance and Operations for distribution of the funds to the recipients. For those not awarded, they are given comments and suggestions and encouraged to apply for the next round.
