






Early Childhood Professional Credential 3.0



ECPC 3.0: OVERVIEW OF CHANGES

Staying the Same:

- · Points-based system
- Four components
- · Each level has point threshold
- Each level has component minimum

Changing:

- · Simpler scoring system
- An application-based process rather than a rolling submission process
- Minimum requirement at Level 3 has changed from 2 to 3 components

EARLY CHILDHOOD COURSEWORK

1 semester credit: 1 point 1 trimester credit: .83 points 1 quarter credit: .67 points

TRAINING OF SPECIAL RECOGNITION

Two points each and the points do not expire

Currently includes: EQIT, Pyramid Colorado Modules (formerly Pyramid Plus Approach Training)

Staying the Same:

- Ability to earn points for early childhood and unrelated degrees
- The more the degree is related to early childhood, the higher the points
- Increased points for higher level of degree
- The cap on points for this component is still 50

Changing:

- Courses no longer expire after 15 years
- No area of study points—they are now wrapped up in the degree points
- New Training of Special Recognition category
- No difference between aligned & unaligned courses

Ongoing Professional Development Component

Maximum points 30

- ONE POINT for every clock hour
- CEUs will be awarded as clock hours—0.1 CEUs = 1 CLOCK HOUR
- Points expire after 3 YEARS

Staying the Same:

- The cap on points for this component is still 30
- Points still expire after 3 years

Changing:

- Each clock hour is worth 1 point—no more tiers
- CEUs will be converted to clock hours and calculated using 1 clock hour = 1 point formula
- No more additional points for QCLEs
- No more additional points for series, high needs, and coaching components

Experience Component

Maximum points 20
(Points do not expire)

- ONE POINT for every 1,820 hours worked in the field
- All experience will need to be accompanied by documentation
- Does not expire
 - Direct work, with young children (birth-8) and families, includes field experiences;
 - 2. Supervision, leadership, or management of programs;
 - 3. Program coordination, development, or regulation;
 - 4. Training, instruction, or technical assistance of programs;
 - 5. Evaluation or research in the field.

Staying the Same:

- The cap on points for this component is still 20
- Points do not expire
- All the types of experience still count

Changing:

• Experience submitted to the new PDIS needs to have documentation

Demonstrated Competencies Component

Maximum points 10

- POINTS awarded when professionals are observed with an approved observation tool and receive a qualifying score
- Expires after 3 YEARS

Staying the Same:

- Still worth up to 10 points
- A variety of tools in this component

Changing:

- This component now figures into the minimum pathway requirement
- Points in this component now expire 3 years after the observation was completed
