

Training Requirements for Family Child Care Homes

Training requirements for Family Child Care Homes include specific required courses and requirements for annual ongoing professional development hours. Please use the charts on the following pages to learn more about the specific training requirements and how to complete them.

Colorado Shines PDIS and Approved Training Vendors

Most of the required training courses are offered free of charge through the Colorado Shines Professional Development Information System (PDIS) at www.coloradoshinespdis.com. The Office of Early Childhood also approves training vendors who offer required courses in an instructor-led format (whether virtual or in a classroom). Required Training for Other Family Child Care License Types

In addition to the standard Family Child Care Home license type, there are four alternative license types that are available. Training requirements for each are outlined below.

Large Family Child Care Home License

If a provider does not meet the experience requirements outlined in 7.707.31C2a & b, completion of one of the following trainings is required.

Three (3) Under Two (2) Family Child Care Home License

A provider must be a Colorado licensed Family Child Care Home provider for 2 years prior to applying for this license type.

Infant/Toddler Family Child Care Home License

A provider must have one year satisfactory, documented experience with infants/toddlers in addition to the following training. See 7.707.31B3 for experience requirements.

Experienced Family Child Care Home License

A provider must be a Colorado licensed provider for 6 years prior to applying for this license type.
